Report from APsaA’s 108th Annual Meeting

During APsaA’s **108th Annual Meeting** this past June in San Diego, the PA Presents Discussion Group featured Susana Rodriguez-Perea, M.S. who presented a case of premature termination to discussant, APsaA’s President-Elect, Dr. William Glover. Co-Chairs Drs. Michael Groat and Bruce Gainsley facilitated this fascinating session.

The following is a brief report from Co-chair Dr. Bruce Gainsley:

This discussion group was very well attended. The presenter is a therapist who lives and works in Tijuana, Mexico. The subject was Making Sense of Premature Terminations. A printed summary was available to the attendees. The discussion focused on transference and counter transference phenomena. The presenter courageously shared a great deal of her reactions to the patient, and the discussant helped the attendees develop formulations regarding the transference issues. The contributions by the attendees were meaningful, and the discussion evolved in a very sophisticated and enlightening manner. During the seminar, I was reminded of an excellent book I read over 10 years ago: Endings and Beginnings by Herbert Schlesinger.

Over the years, I have attended numerous group discussions for psychotherapists, and this was amongst the best.

PA Committee News

The PA Committee continues with Co-Chairs Margo Goldman, MD, and Simone Hoermann, PhD, and members Petra Pilgrim, MD, Michael Groat, PhD, Jonathan Kersun, MD, Bruce Gainsley, MD, Jacques Gourguechon, MA, LPC, and Linda Michaels, PsyD; Carol Reichenenthal, PhD, remains an emeritus member. Due to several members' job-related moves, we now need representation from the Southwest, Southeast and Pacific Northwest. The PA committee continues its E-Newsletter (with new editors, Drs. Kersun and Pilgrim), and organizes educational programs and networking events at APsaA's Meetings. The Committee collaborates with the Committee on Psychoanalytic Psychotherapy Training Directors (COPPT) and recently acquired representation on APsaA's Membership Committee (Linda Michaels), Scientific Program Committee (Michael Groat) and the newly formed Psychotherapy Task Force (Linda Michaels and Simone Hoermann). Committee member Linda Michaels liaisons with the Psychotherapy Action Network (PsiAN) to bolster psychodynamic psychotherapy practice (see Linda's PsiAN update below). *We appreciate committee members' commitment and hard work!*

We received the Psychotherapist Associates Survey responses and greatly appreciate those of you who took the time to complete the questionnaire. We sent out the survey to 275 PAs and 126 answered. Of note, the large majority of respondents (93.5%) support full APsaA membership. The main reasons people joined as PAs were networking opportunities and conference content. As a result of the survey, we are working on finding ways to improve upon the exceptional benefits offered to PA's including strengthening the PA community's feeling of connection to the larger APsaA community. As always, we welcome your feedback and ideas.

Due to the growth of PA programs and costs required to implement them, we regretfully found it necessary to modestly increase dues from \$100/year to \$125/year. This occurred in the context of having no dues increase for at least 10 years, and will be reflected in your upcoming 2020 PA renewal request.

The Psychotherapy Action Network (PsiAN) is a nonprofit organization dedicated to advocating for therapies of depth, insight and relationship. Together with our Strategic Partners -- one of which is APsaA -- we work to educate and advocate with legislators and policy-makers, fellow professionals and the public to increase awareness and understanding, as well as assure the availability of optimal mental health treatments for those who need it most.

PsiAN was formed following a multidisciplinary conference held in Chicago in 2017. The conference aimed to explore the threats to psychotherapy posed by legislation, insurance policies, marketplace interests, biases in research and training, and cultural pressures, but also to suggest hopeful directions for collective action. PsiAN's Branding Project team continues to work on **re-branding therapy in the public eye**.

Why is this so important? Psychoanalytic psychotherapy/psychoanalysis has a branding problem. We have been out-positioned and negatively branded by powerful industries and interest groups. The treatments we offer are perceived as antiquated, never-ending, too expensive and only for the privileged.

Yet, we know in profound ways that this is not true.

Our team of volunteer marketing, advertising and market research experts has been working diligently on this branding problem, applying the same tools and strategies that corporate America uses. We have conducted three iterative waves of qualitative research – in-depth, 1-on-1 interviews with over 30 individuals. We are working on quantitatively testing the learnings and hypotheses that resulted from this qualitative research.

While PsiAN does pretty much everything on a pro bono, 100% volunteer basis, this quant research is something we need to hire out. Recent presentation on psychoanalysis

PsiAN presented a panel of papers at the annual meeting of the American Psychological Association in August 2019. The theme of the APA conference was “othering,” and PsiAN decided to take a look at the treatment of psychoanalytic thought and therapies through that lens. Our panel was called The Othering of Psychoanalysis, and Oksana Yakushko, Linda Michaels, and Janice Muhr presented papers, with a discussion by Nancy Burke.

These presentations look in turn at the history of Freud bashing in the United States through the lens of psychology’s historic ties to eugenics; the evidence base for psychoanalytic therapies; and PsiAN’s efforts to transcend the effects of marginalization.
